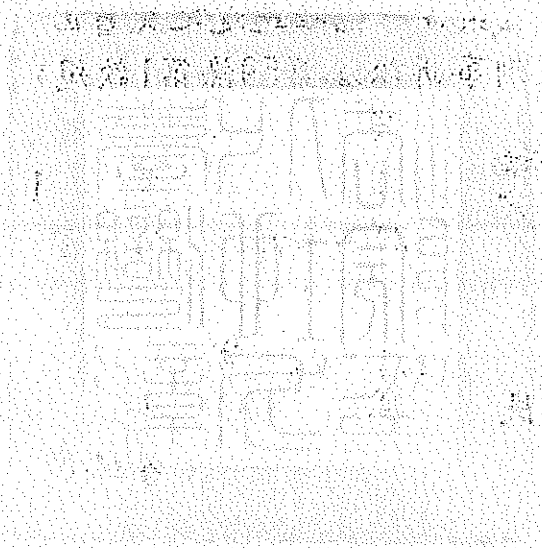

A witness who fails to appear in court without legal justifications upon a legal subpoena, the court may adjudicate a penalty of thirty thousand NT dollars and take the witness into custody. The same rule shall be applied for a second failure of appearance.<br>3. The person summoned shall appear in court with appropriate attire, and report on time with his/her identification and this notice. This notice is free of charge. If the person summoned wishes to produce any documents, he/she shall indicate the case number and the cause of action on the document<br>4. If the person summoned has new evidences available for investigation, please bring it to court; if there are requests for the investigation of new witnesses, please ascertain the name and address for the convenience of summoning.<br>5. After interrogation, witnesses may proceed to the responsible clerk and request for an "application/receipt of daily/viaticum fees" and consequently claim such legally assigned payment. (However, a witness who is subjected to custody or, without legal iustifications. refuses to take an oath or testifv is excluded from<br>6. If confronted with natural disasters, and the authority of the municipal city/county at which this court is located declares an official day off, please do not appear in court until further notice.<br>7.
